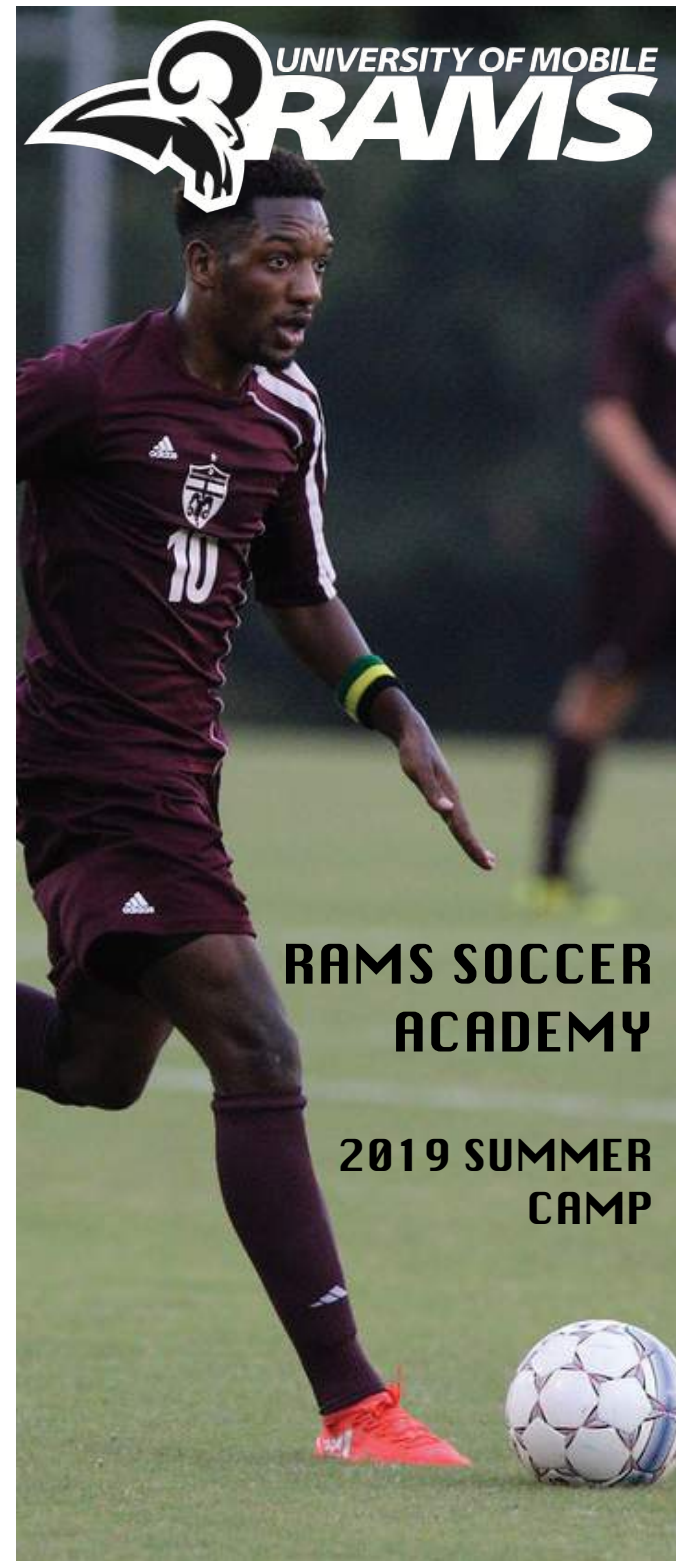

**ASSUMPTION OF RISK 1.1** The undersigned has been fully and completely advised of the potential dangers incidental to engaging in the activity and instructing of Soccer. The undersigned fully understands that there is the risk of serious injury or death while participating in athletic activities at the Rams Soccer Academy, LLC camp at University of Mobile. **1.2** Because of the dangers of participating in athletic activities, the undersigned acknowledges the importance of following instructions from the coaching staff regarding playing techniques, training, equipment and rules. **1.3** The undersigned hereby asserts his/her participation in athletic activities is voluntary and he/she knowingly assumes any and all such risks of athletic participation.

**WAIVER OF LIABILITY 2.1** The undersigned hereby voluntarily releases, discharges, waives and relinquishes any and all actions or causes of action for personal injury, property damage, death, or loss of any kind whatsoever occurring to him/herself arising as a result of engaging or receiving instructions in said activity or activities incidental thereto wherever or however the same may occur and for whatever period said activities or instructions may continue. **2.2** The undersigned does for him/herself, his/her heirs, executors, administrators and assigns hereby release, discharge, waive and relinquish any action or cause of action, aforesaid, which may hereafter arise for him/herself and for his/her estate, and agrees that under no circumstances will he/she or his/her heirs, executors, administrators and assigns prosecute, present any claim for personal injury, property damage, death or loss of any kind whatsoever against the Rams Soccer Academy, LLC, University of Mobile, Daniel Whelan, Brian Person, instructors, coaches, athletic trainers, or student trainers for any of said causes of action, whether the same shall arise by the negligence of any of said persons, or otherwise.
